At each of the first two organizations, Delta Theta Phi Law Fraternity and Education Law Association, she worked with very small with equally small budgets and little or no staff. Those organizations were based on the membership of individuals. She had to increase the association's income while finding creative ways to meet the members' needs, heavily relying on volunteers. While working for ELA, Kurela Smith completed a Master's of Public Administration degree from the University of Dayton. Her JD and MPA could be useful for any lobbying efforts at the state or federal level, as it is sometimes helpful in getting a foot in the door of places that otherwise would be closed. Her current organization, the Precision Machined Products Association, is based on the membership of companies. Working for PMPA has expanded her understanding of the issues industry colleagues in larger associations face. PMPA, a c-6 trade association, has a staff of nine, plus a PAC, an educational foundation and a for-profit corporation. Her work history and prior service can offer a balance of knowledge and experience which will be helpful in her service to the OSAP Board of Directors. The PMPA office is located in Brecksville, between Akron and Cleveland, which is also advantageous for Kurela Smith to make an effort at personal outreach to associations in both those areas.
